

Trade, Exhibition and Concessions Frequently Asked Questions

When are the Tall Ships Races 2023?

The Tall Ships will be in Hartlepool from Thursday 6th to Sunday 9th July 2023.

How do I apply?

We will email you a link to the application when it goes live on Friday 3rd February 2023. The form will also be available from our website. Once you have completed the form we will notify you if your application is successful and include a payment invoice. Applications will not be fully confirmed until payment is received.

Is there a closing date for applications to be submitted?

Applications are on a first come, first serve basis. We anticipate a high demand, so would recommend applying as early as possible.

All businesses are welcome to apply, you will be asked for more detail on the application form, as well as

What types of businesses are welcome?

photos of your proposed stall/offer. We would encourage businesses think about a maritime or nautical theme for their stand to fit in with the theme of the overall event.

Stalls are open to everyone, however, the selection criteria prioritises local applicants.

Are stalls only available for local businesses?

The event will be open to the public on Thursday, Friday and Saturday from 10am-11pm.

On Sunday the opening times are 7am-5pm.

What are the event opening times?

Do I have to be there every day? Yes the event is 6-9 July 2023, single day applications are not accepted and you are not permitted to

Do I have to stay open until the public closing time?

On Thursday, Friday and Saturday minimum trading times are 10am-7pm. On Sunday the minimum trading times are 7am-5pm. You are encouraged to stay open as long as the public are on site.

How big are the stands?

Can I sell alcohol?

Will I need to supply my own gazebo?

You are only able to bring a gazebo if you are applying for a free standing place. You will be required to submit detailed information on the type of gazebo and plans on how you will weigh it down, this needs to be included in your risk assessment. A market stall or trade stand is unable to have a gazebo over it or

Am I responsible for my space?

You are responsible for keeping your space tidy and clear of rubbish. The space should be maintained and returned to us as you found it. What if I need power?

Please notify us on application your requirements for the stand such as wifi access and power

requirements. Can I put on music on my stand?

Amplified music and PA systems are not permitted without out our prior written permission.

Hartlepool Borough Council are committed to providing a sustainable event, we expect all applicants to adhere to the Tall Ships Sustainability Policy, found here. We would like no single use plastic on site and would like all packaging to be recyclable.

Can I use any packaging?

Is it a cashless site? Applicants can apply for wifi on the site for the use of card machines where required, please identify
